# **5. OLD BUSINESS**

• All 63 lots of the Springhurst subdivision are covered by the <u>restricted covenants.</u>

- Our SHOA is 100 legal and can enforce bylaws and restricted covenants.
- Seven homeowners were taken to court for non-payment of their annual homeowners fees. Their cases were dismissed without prejudice. SHOA can file a new suit on the unpaid assessments. The HOA can file a judgment against homeowners for the unpaid assessments as well as reasonable attorney's fees incurred, and the attorney's fees can be more than the HOA assessments.

### **6. NEW BUSINESS**

- As of January 2025, the homeowner's annual dues will be \$75.00 a year, which should be \$4,700 for all 63 lots.
- Easements need to be cleaned on behalf of Garden Valley as well as the buffer zone.
- Welcome Ladonna Johnson to the SHOA! Her role will be Newcomers.
